The eTech program offers incentives to Entergy customers who purchase select electric equipment. Cash incentives are currently available to qualifying customers for purchasing the following equipment:

| Electric Technology |  Entergy Cash Incentive |

Electrification Consultation

If you are unsure of how potential electrification opportunities could improve your equipment or processes, you can sign up for a free electrification consultation. Our local program representative will walk through your facility and help you identify potential custom rebate opportunities that could help you and your employees enjoy the benefits of electrification upgrades.

Do I Qualify?

- Applicants must install electric equipment and/or infrastructure at a facility that has electric service billed under an Entergy electric rate.
- Equipment must:
 - Replace an internal combustion unit, or
 - Be a first-time electric equipment purchase/lease, or
 - Be an expansion to an existing fleet.
- Electric equipment replacing electric equipment does not qualify.
- Leased electric equipment may be eligible for the full incentive.
- Used electric equipment are eligible for a reduced incentive based on the useful life of the equipment.

Applying is easy.

Visit <http://entergyetech.com/apply-online/> to fill out the application form, and an eTech field representative will contact you to finalize the application.

To complete the application process, you will need:

- A valid Entergy account.
- A copy of an equipment invoice or valid proof of purchase.
- Submit incentive application and documentation within 180 days of delivery or invoicing.
- Note that electric equipment purchased to replace older equivalent electric equipment does not qualify for the cash incentive.
